# Organizers 主辦方



The **China Public Administration Review (C-PAR)** was launched in December 2019, preceded by a continuous publication series under the same name from 2004. The journal is based at the School of Public Policy and Management, Tsinghua University, and published by Tsinghua University Press. C-PAR

has established an academic committee and editorial board composed of renowned scholars in the field. The editor-in-chief manages the daily operations of the journal, assisted by the editorial office. Currently, it is issued quarterly. C-PAR is an indexed journal in the CSSCI (Chinese Social Sciences Citation Index), AMI Core New Journal, and a Key Magazines of China Technology.

C-PAR is committed to academic integrity and adheres to rigorous standards for paper publication. It invites lead editors from outside Tsinghua University to manage the review process following the rules of double-blinded peer review. It aims to connect public administration practice in China's context with rigorous theories in the discipline of public administration. It encourages more evidence-based research derived from and directed toward practice. The journal has continuously refined its submission and review processes with the support of reviewers and authors, advocating for more open dialogue among them. It has actively participated in academic community-building alongside other journals and academics. Regular columns include original research articles, practical perspectives, seasonal reviews of outstanding English and Chinese articles, and others.

Since 2021, C-PAR has been organizing the “One Hour for Young Talents” workshop series, aiming to provide early-career scholars with opportunities for deep academic exchange. Each workshop session accepts between 5 to 8 papers, with each paper discussed for one hour. The “One Hour” discussion proceeds as follows: an invited expert discussant will introduce the paper from a reader's perspective and provide an in-depth review for 20~25 minutes, followed by the author responding to the discussant's comments for 10~15 minutes, and then 10~15 minutes of in-depth on-site discussion.



# Organizers 主辦方



《公共管理評論》於2019年12月創刊，前身是2004年創辦的同名連續出版物（中文社會科學引文索引CSSCI來源集刊），是由清華大學主辦的公共管理和公共政策專業學術出版平台。期刊由教育部主管，清華大學主辦，由清華大學公共管理學院負責日常學術運營。期刊由清華

大學出版社出版，現階段每年出版四期。期刊設有學術委員會和編委會，實行主編負責制。期刊於2021年入選CSSCI來源期刊（擴展版），2022年入選中國人文社會科學綜合評價（AMI）新刊核心期刊，2023年入選CSSCI（2023-2024）來源期刊，2024年入選中國科技核心期刊。

《公共管理評論》堅持學術為本，遵循嚴格的學術標準，特邀固定服務期限指導編輯具體負責期刊審稿管理，依據“雙向匿名，學術迴避”原則進行審稿工作，確保同行評議成為論文錄用的核心依據；堅持“植根本土、面向世界”的學術立場，倡導“源於實踐、指向實踐”的實證學風，為相關領域研究者提供一個高水平的學術交流平臺；期刊秉持服務學術共同體的理念，在審稿人和作者的支持下不斷優化投審稿各環節工作，倡導坦誠對話學風；與兄弟期刊和學界賢達一起積極參與學術共同體建設，構建優質交流平臺。本刊常年開設原創論文、實踐視野（案例研究專欄）、當季英文佳作評介、當季中文佳作評介等欄目。

《公共管理評論》自2021年發起舉辦“給青年一小時”工作坊活動，旨在為處學術生涯早期的青年學者提供深度交流學習機會。工作坊每期接收5~8篇論文，每篇論文討論一小時。“一小時”討論流程為：一位資深點評人從讀者視角介紹論文並予以深度點評20-25分鐘，青年作者現場回應點評專家的意見10-15分鐘，現場深度研討10-15分鐘。

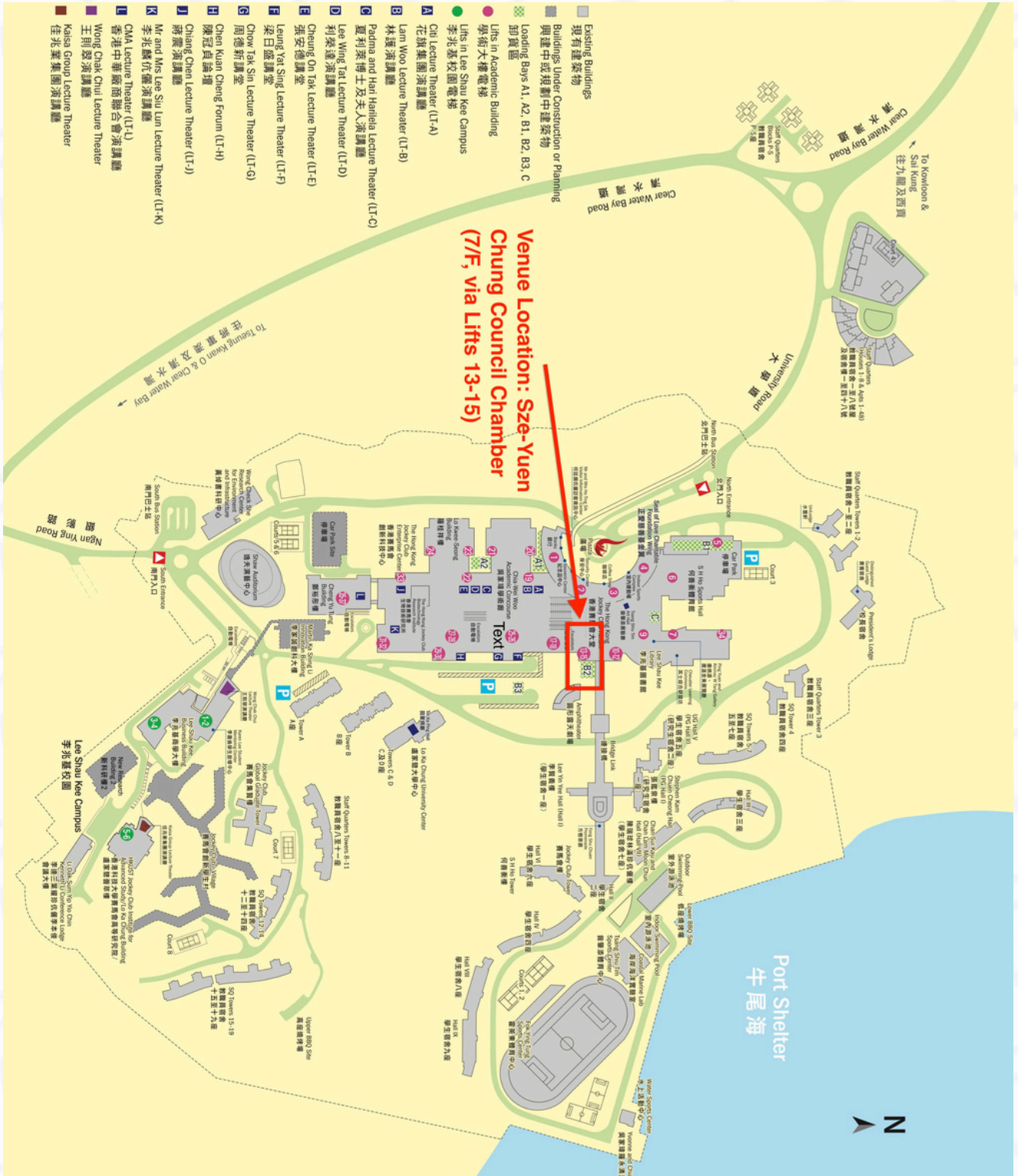
**ZHAN Jing Vivian 詹晶**
