Tim K.T. CHENG Vice President (Research & Development), HKUST

Prof. Tim Cheng Kwang-Ting, Vice-President for Research and Development at HKUST since April 1, 2022, is a renowned scholar in electronics testing, design verification, and cross-disciplinary research. With a PhD from UC Berkeley, he joined HKUST in 2016 after a distinguished career at UC Santa Barbara and AT&T Bell Labs. Prof. Cheng has held key academic roles and managed substantial research funding. He has an extensive publication record, authored books, and holds multiple patents. Dr. Nima Asgari has worked as a public health physician since 2000. Dr. Chen leads the Interdisciplinary Approaches to Social Determinants of Health Pre-Seed Team at UGA and has published over 100 peer-reviewed articles in leading journals, including *Lancet*, *Journal of Health Economics*, and *Social Science & Medicine*. In 2013, he was honored with the CDC Excellence in Social and Behavioral Science Research Award.

Dr. Jin Xu is an Assistant Professor specializing in health policy and systems research at Peking University China Center for Health Development Studies. His research primarily involves the evaluation of health system interventions, particularly related to primary care strengthening, hospital financing, integrated care, and digital health. He has overseen various research projects funded by organizations such as the Natural Science Foundation of China, China Medical Board, National Health Committee of China, and the World Health Organization. Additionally, he serves as an external supervisor for the University of Manchester and is a fellow of the Equity Initiative.

Dr. Alex Jingwei He is a tenured associate professor at HKUST's Division of Public Policy. Dr. He has a prolific publication record in top international journals and is ranked in the world's top 2% of cited scientists in public administration and political science for two consecutive years. His publications appear in leading international journals including Social Science & Medicine, Health Policy, Health Policy & Planning, Governance, and Policy Sciences. Dr He is a key member of research consortium funded by the Asia-Pacific Observatory on Health System and Policies. He serves as the Associate Editor of Policy & Society and Journal of Asian Public Policy.

Previously, he was Associate Dean for Executive Education and Research at the Lee Kuan Yew School of Public Policy, National University of Singapore. Prof. Low also served 15 years in the Singapore government, founding the Centre for Public Economics and holding key roles in the Ministry of Finance and the Public Service Division. Prof. Low holds a double first in Politics, Philosophy, and Economics from Oxford University and a Master's in International Public Policy from The Johns Hopkins University's School of Advanced International Studies.

Prof. David Bishai, a Clinical Professor in Public Health and the Director of the School of Public Health at the University of Hong Kong, brings substantial expertise to his role. He previously served as a Professor at the Johns Hopkins Bloomberg School of Public Health for 27 years and worked as a health officer for Maryland in 2021. His research focuses on global public health performance, financing, primary healthcare, vaccines, and health disparities, resulting in two books and over 260 peer-reviewed publications. He has also secured USD50 million in grant support from various institutions. Additionally, as the President of the International Health Economics Association, he established a global mentoring network for early career researchers. Prof. Bishai holds certifications from the American Board of Internal Medicine and the American Board of Pediatrics, and he earned degrees from prestigious institutions, including Harvard, UCLA, UC San Diego, and the Wharton Business School at the University of Pennsylvania.

Mr. Martin Chew assumed the role of Director (Aged Care Services) in November 2021. He is responsible for overseeing the strategy, planning, and development of aged care services, encompassing both home and community-based services, as well as palliative care. Prof. Woo's research interests encompass chronic diseases and geriatric syndromes, health services research, nutrition epidemiology and intervention, and quality of life issues at the end of life. She has published over 1000 articles in peer-reviewed indexed journals.

Naubahar's research has had a demonstrable impact on business and his research was one of HKUST's few 'impact case study' submissions (sole-authored) for its 2020 Research Assessment Exercise (RAE).

Prof. Madhurima Nundy is a Fellow in Health and Human Development at the Centre for Social and Economic Progress in New Delhi. Additionally, she holds the position of Honorary Fellow at the Institute of Chinese Studies (ICS) in Delhi, India. She earned her PhD in Public Health from the Centre of Social Medicine and Community Health at Jawaharlal Nehru University, New Delhi. Her areas of interest encompass researching health systems, health policies, the commercialization of healthcare, and health inequalities. She also utilizes comparative frameworks to study health systems. With several publications to her name, she is a regular contributor to policy analysis in the field of public health in China and India. Prior to her current roles, she served as Assistant Director and Fellow at ICS, Delhi (2012-2021) and as a Senior Programme Coordinator at the Public Health Resource Network in New Delhi (2009-2012).

Dr. Haruka SAKAMOTO is an Associate Professor at the Department of Hygiene and Public Health, Tokyo Women's Medical University. She earned her M.D. from Sapporo Medical University and worked as a primary care physician at St. Luke's International Hospital. Subsequently, she obtained her MPH from the Harvard School of Public Health and a PhD in public health from the University of Tokyo in 2021. Dr. Sakamoto also gained experience at the international cooperation department of the Ministry of Health, Labour, and Welfare of Japan, where she was deeply involved in health policy activities in Japan. She is currently affiliated with the WHO Western Pacific Regional Office, the Tokyo Foundation for Policy Research, and the Health and Global Policy Institute (HGPI).

Speech Title: Lessons from Japan: Towards the Realization of an Inclusive Society Challenged by the World's Most Aged Country



Hongsoo Kim Professor, Graduate School of Public Health, Seoul National University, South Korea

Dr. Hongsoo Kim is a professor of health policy and aging at the Graduate School of Public Health and serves as the director of the Center for AI in Health and Care at the Artificial Intelligence Institute at Seoul National University (SNU), South Korea. Her research areas include aging and health policy, long-term care systems, health-care system performance and evaluation, and care innovation. She has led numerous government-funded research projects and participated in reviews of health and long-term care policies at various levels. Dr. Kim was a Fulbright Visiting Scholar & Takemi Fellow in International Health at Harvard School of Public Health (2016-2017). She has received an AXA Research Award (2016) and a Humboldt Research Fellowship (2019). Dr. Kim is currently an expert member of the WHO advisory group for the UN Decade of Healthy Aging (2021-2030).

She earned her PhD from New York University and worked as an assistant professor before joining SNU.

Post-doctoral Research Fellow, Centre for AI in Health and Care, AI Institute, Seoul National University, South Korea

Dr. Sunghun Yun is a postdoctoral researcher specializing in health systems and policy research. Sunghun earned a Ph.D. in Health Policy and Administration and an M.P.H. from Seoul National University, following a doctoral degree in traditional Korean Medicine. Dr. Yun has experience practicing as a public health physician in rural areas and public long-term care hospitals. His current research focuses on the long-term care system, particularly in finding the most effective and efficient ways to support aging in place for older people, with the ultimate goal of achieving a healthy aging society. He is particularly interested in addressing potential inefficiencies resulting from fragmented service delivery systems and believes that patient empowerment, strategic purchasing, and technology can help overcome these issues.

Dr. Peishan Yang is a Professor in the Department of Social Work and serves as the Director of the Research Ethics Center at National Taiwan University (NTU). Dr. Yang also holds the position of Chief Editor of NTU Social Work Review, which is ranked as the No.1 Social Work Journal in Taiwan. She has an extensive body of work, including numerous publications in high-impact academic journals. Dr. Yang also serves as a member of the editorial boards for Global Health Research and Policy and Aging and Health Research.


